TBSC belongs to you, the members, and is run entirely by volunteers to the benefit of all members; your club has no employees or staff. Every member is expected to carry out a minimum of two duties each year, without which the club will not function. Every day that we open during the season we need one committee member to be on hand as duty manager, two volunteers to run the races, two to helm and crew the support boat and one or two people running the bar and snacks. We have been fortunate in recent years that two of our members have given generously of their time so that one race duty and the helm duty are covered most weeks. That still leaves a requirement for three or four members to volunteer for duties each Sunday. Membership & Boat Fee Types

Payment Conditions (All Fees)

- Members renewing their membership who pay in full (including boat storage) by 31st December can deduct £10 from the appropriate fee above. Note: there is no discount for Social members.
- Members renewing their membership can pay their subscription in 4 equal instalments on or about 30th November, 31st December, 31st January and 28th February, but will not receive the £10 discount. Members wishing to pay their subscription in instalments should notify the Honorary Treasurer of their intention by no later than 30th November.
- Any member not paying their subscription in instalments (as per 2 above) who does not pay any fees due by 31st January will cease to be a member of the club and will not be entitled to the benefits of membership. Lapsed members who wish to rejoin will have to pay the joining fee (as if they were a new member) + the appropriate Membership Category fee.

There are the following classes and types of membership.

Memberships (for sailing Members)

A). Family Membership. An adult, or 2 adults living as a couple, plus their children up to the age of 17 (up to 21 if still full time student).	£160.00
B). Couple Membership. 2 adults living as a couple	£150.00
C). Single Membership. Aged 18 and over (or over 21 if still in full time student)	£140.00
D). Cadet Membership. Any member between 12 - 17 (or 21 if still full time student) not otherwise covered by Family Membership.	£45.00
E). Junior Cadet Membership. Any member between 8 - 11, not otherwise covered by Family Membership.	£45.00

Non-Owner Memberships (for sailing Members)

This scheme is for new (or current) members wishing to make use of the club boats instead of buying and maintaining their own. Any member(s) wishing to take advantage of the scheme pays the full membership amount applicable to their requirements (i.e. Family, Couple, and Single Memberships), plus a notional **£55** boat parking fee. But instead of this fee covering a boat park space, it allows them use of any of the club boats throughout the season.

The only conditions are:

- Club boats can only be used during scheduled club sailing sessions, when there is Support Boat cover on duty. (Not during other times of the week.)
- During Taster Days and any Club Training Days priority for club boats is given to Training Sessions.

So the equivalent Yearly Fees for each Non-Boat owning membership category are:

A). Family Membership. An adult, or 2 adults living as a couple, plus their children up to the age of 17 (up to 21 if still full time student).	£215.00
B). Couple Membership. 2 adults living as a couple	£205.00
C). Single Membership. Aged 18 and over (or over 21 if still in full time student)	£195.00
D). Cadet Membership. Any member between 8 - 17 (or 21 if still full time student) not otherwise covered by Family Membership. N.B. Cadet members already get free use of club boats.	£45.00

Social Memberships (for non-sailing Members)

Social Members will be entitled to the rights and privileges under the Club Rules EXCEPT:

- The right to vote.
- Those Rules, Byelaws, and Regulations restricted to sailing matters.
- They will not be eligible to store boats and/or sailing equipment on the club premises or to use club boats and/or sailing equipment, however they may sail as crew with members on members' boats

The types of Social Membership shall be:

Boat Parking

Boats / Trailers abandoned & Fees not paid

In accordance with Club Byelaws, I/We accept that if at any time membership or storage fees are over 3 months in arrears:

The Committee shall be entitled to move my/our craft to any other part of the club premises without being liable for any loss or damage howsoever caused.

The Committee shall be entitled upon giving one months notice in writing to me at my last known address as shown in the register of members, to sell my/our craft and deduct any monies due to the club (whether by arrears of subscription, storage fees or otherwise) from the net proceeds of sale before remitting the balance, if any, to myself.

Alternatively, any craft which in the opinion of the Committee cannot be sold upon such notice as aforesaid may be disposed of in any manner the Committee thinks fit and the expenses recovered from myself. Any arrears aforesaid shall be deemed to be a debt owing to the club by myself.

Further, the club shall at all times have a lien over my craft parked on the club's premises in respect of all monies due to the club, whether in respect of storage fees, subscriptions or other arrears.

Parking on the beach

As of 2015 Canterbury City Council (CCC) have given us permission to park boats on several sections of the beach (the sections that stretch parallel with the already allocated area along the grass bank). But, if you are allocated a beach parking spot, you need to be aware that these spots are only allowed to be used during the sailing season (Stipulated by CCC as being between 1st April - 30th October). Outside of these dates, during the winter season **ALL** boats parked here **MUST** be moved, either to the grass bank, or taken home.
